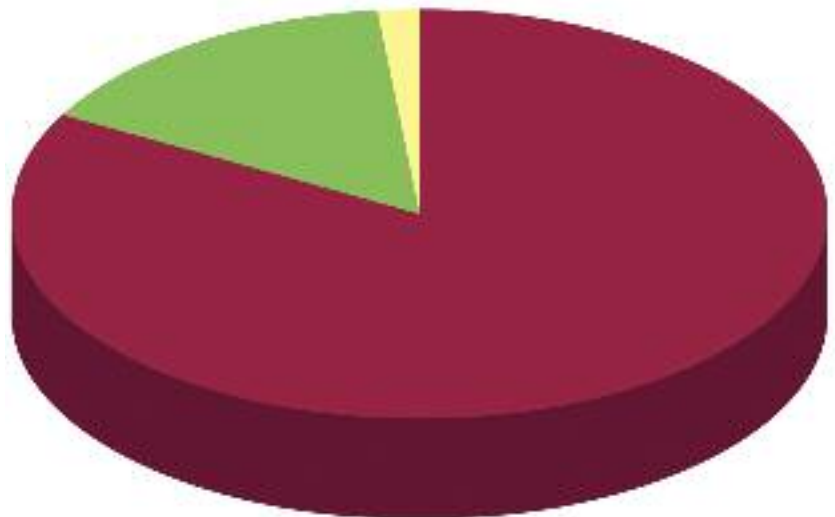


Operating Revenues & Support for the year ended June 30, 2011
